

Privacy Policy

In the course of using Ramanathapuram District Central Co-operative Bank website or mobile application availing the products and services vide the online application forms and questionnaires, Ramanathapuram District Central Co-operative Bank and its affiliates may become privy to the personal information of its users, including information that is of a confidential nature.

Ramanathapuram District Central Co-operative Bank is strongly committed to protecting the privacy of its users and has taken all necessary and reasonable measures to protect the confidentiality of the user information and its transmission through the world wide web and it shall not be held liable for disclosure of the confidential information when in accordance with this Privacy Commitment or in terms of the agreements, if any, with the users.

Ramanathapuram District Central Co-operative Bank endeavours to safeguard and ensure the security of the information provided by the user. The user would be required to co-operate with Ramanathapuram District Central Co-operative Bank in order to ensure the security of the information, and it is recommended that the users necessarily choose their passwords carefully such that no unauthorised access is made by a third party. The users should undertake not to disclose their password to anyone or keep any written or other record of the password such that a third party could access it. Ramanathapuram District Central Co-operative Bank undertakes not to disclose the information provided by the users to any person, unless such action is necessary to:

- 1. Conform to legal requirements or comply with legal process;
- 2. Protect and defend Ramanathapuram District Central Co-operative Bank's or its Affiliates' rights, interests or property;
- 3. Enforce the terms and conditions of the products or services; or
- 4. Act to protect the interests of Ramanathapuram District Central Co-operative Bank, its Affiliates, or its members, constituents or of other persons.

The users shall not disclose to any other person, in any manner whatsoever, any information relating to Ramanathapuram District Central Co-operative Bank or its Affiliates of a confidential nature obtained in the course of availing the services through the website. Failure to comply with this obligation shall be deemed a serious breach of the terms herein and shall entitle Ramanathapuram District Central Co-operative Bank or its Affiliates to terminate the services, without prejudice toany damages, to which the user may be entitled otherwise.

Ramanathapuram District Central Co-operative Bank will limit the collection and use of user information only on a needto-knowbasis to deliver better service to the users. Ramanathapuram District Central Co-operative Bank may use andshare the information provided by the users with its Affiliates and third parties forproviding services and any service-related activities such as collecting subscriptionfees for such services, and notifying

or contacting the users regarding any problemwith, or the expiration of, such services. In this regard, it may be necessary to disclosethe user information to one or more agents and contractors of Ramanathapuram District Central Co-operative Bank andtheir sub-contractors, but such agents, contractors, and sub-contractors will be required to agree to use the information obtained from Ramanathapuram District Central Co-operative Bank only for these purposes.

The user authorises Ramanathapuram District Central Co-operative Bank to exchange, share, part with all information related to the details and transaction history of the users to its Affiliates / banks /financial institutions / credit bureaus / agencies/participation in any telecommunication or electronic clearing network as may be required by law, customary practice, credit reporting, statistical analysis and credit scoring, verification or risk management andshall not hold Ramanathapuram District Central Co-operative Bank liable for use or disclosure of this information.

Any information that is freely available or accessible in public domain or furnished under the right to Information Act, 2005 or any law for the time being in force shall not be regarded as data or information for the purpose of this and the bank shall not be responsible for the same. The Bankfrom time to time may change this policy.

The privacy practices set forth in this policy are for www.rdccbank.co.in website and mobile application only. Ramanathapuram District Central Co-operative Bank website may contain links to other websites of similar interest. However, once user click these links and leave the bank's website, user should note that Ramanathapuram District Central Co-operative Bank does not have any control over other websites. Therefore, Ramanathapuram District Central Co-operative Bank cannot be responsible for the protection and privacy of any information which user provide whilst visiting such websites and such websites are not governed by this privacy statement.
